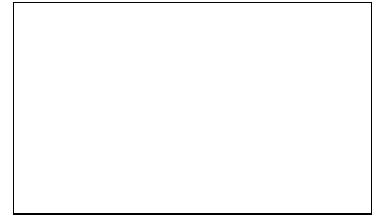

DATA PROTECTION CLAUSE
